### Eligible Breeds and Registry:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets and Provisional breeds, if any, may be entered in the regular stakes. Limited stake breeds, if any, may be entered in Limited Stake. Limited breeds currently include purebred Chart Polski, Cirneco dell'Etna, Galgo Español, Magyar Agar, Peruvian Inca Orchid and Portuguese Podengo. All entries in the regular stakes shall be individually registered with the American Kennel Club, the United Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Limited and/or Provisional stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

### Stakes Offered

**OPEN:** Any eligible sighthound, excluding ASFA Field Champions of record.

**FIELD CHAMPION:** Any ASFA Field Champion.

**VETERAN:** Any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Whippets and Ridgebacks, whose age shall be at least seven years.

**LIMITED:** Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements.

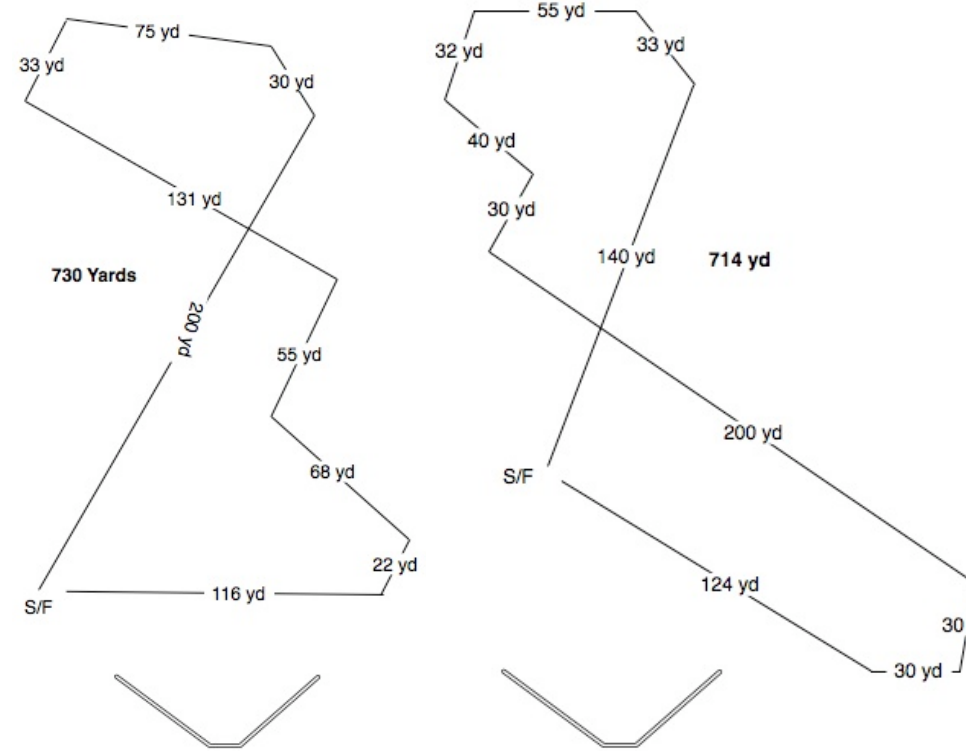
**SINGLES:** Any eligible sighthound including those disqualified to run in other stakes. (Limit 10 entries)

### BEST IN FIELD WILL BE OFFERED

Conditions of Entry: Hounds must be one year or older on the day of the trial and will be examined for breed disqualifications – spayed, neutered, monorchid and cryptorchid hounds without breed disqualifications may be entered • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified • If hounds owned or co-owned by the same person are not to run together, the owner must state this on the entry form • Stakes will be split into flights by public random draw if the entry in any regular stake 20 or more • Battery-powered continuous loop lure machines will be used, with backup equipment on site • The lure will consist of highly visible white plastic strips and/or fur strips • A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound.
