Entries will NOT be acknowledged by mail. Late, incomplete, or unpaid entries will not be accepted. There will be a \$25 fee for any returned check.

### Eligible Breeds and Registry:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets and Provisional breeds, if any, may be entered in the regular stakes. Limited stake breeds, if any, may be entered in Limited Stake. Limited breeds currently include purebred Chart Polskis, Galgo Españols, Magyar Agars, Peruvian Inca Orchids and Portuguese Podengos. All entries in the regular stakes shall be individually registered with the American Kennel Club, the United Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Limited and/or Provisional stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for hounds registered with the National Greyhound Registry.

### Stakes Offered

**OPEN:** Any eligible sighthound, excluding ASFA Field Champions of record.

**FIELD CHAMPION:** Any ASFA Field Champion.

**VETERAN:** Any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Whippets and Rhodesian Ridgebacks, whose age shall be at least seven years.

**LIMITED:** Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements.

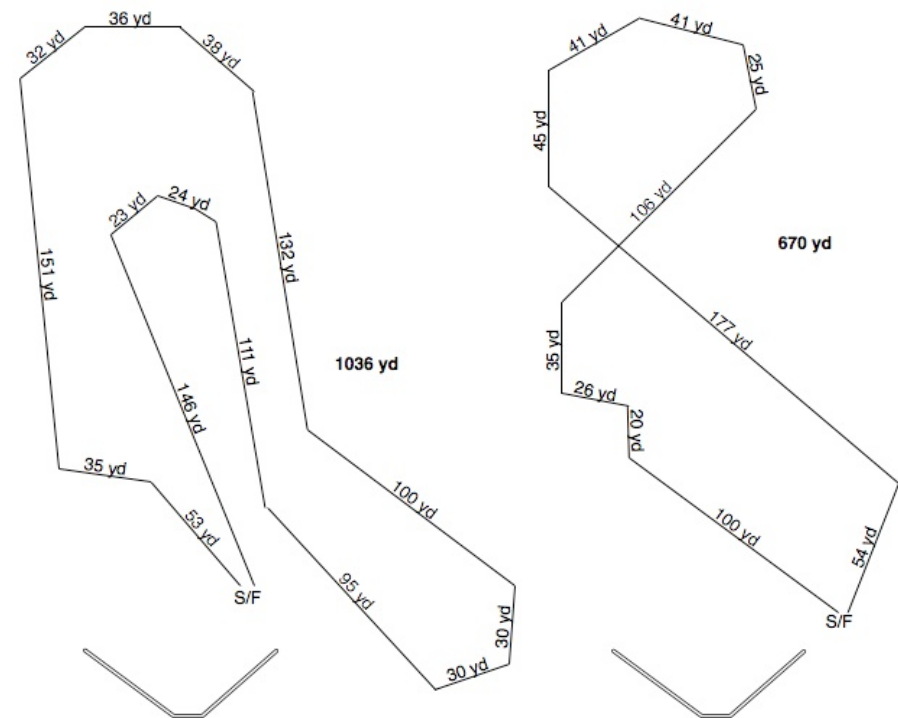
**SINGLES:** Any eligible sighthound including those disqualified to run in other stakes. (Limit 10 entries)

#### BEST IN FIELD WILL BE OFFERED

Conditions of Entry: Hounds must be one year or older on the day of the trial • Bitches in season, larr hounds and hounds with breed disqualifications will be excused at roll call • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered • Hounds with breed disqualifications are not eligible to enter except in the Singles Stake • Hounds not present at the time roll call will be scratched • All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified • If hounds owned or co-owned by the same person are not to run together, the owner must state this on the entry form • Stakes will be split into flights by public random draw if 1 entry in any regular stake is 20 or more • Battery-powered continuous loop lure machines will be used with backup equipment on site • The lure will consist of highly visible white plastic strips and/or fur str • Course may be altered as required by weather or field conditions • A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound.
