#### *Eligibility*

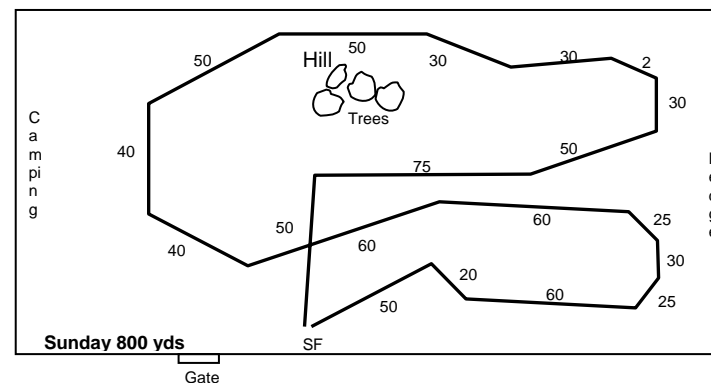
Only purebred Salukis may enter. All entries shall be individual registered with the American Kennel Club, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a critique case number from the Society for the Perpetuation of the Desert Bred Saluki. Spayed, neutered, monorchid and cryptorchid hounds are eligible.

#### *Stakes Offered*

**Open:** Any saluki that has met certification requirements, excluding ASFA Field Champions of record. **Field Champion:** Any ASFA Field Champion saluki. **Veteran:** Individual salukis whose age is at least six years. **Single Stake:** Any eligible saluki, certification not required. (Limit 10 hounds). All entries must be at least one year of age. **New Open entries need to include certification as well as registration. Certification runs for Salukis will be offered after all trials.**

Stakes will be split into flights by public random draw if entry in any regular stake is 20 or more. Hounds not present at roll call will be scratched. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. Neutered and monorchid hounds may be entered. The lure will consist of plastic strips and/or fur in a battery-operated, continuous loop system. The course will be reversed for the finals, tie run-offs, and BOB. HVSC reserves the right to alter the course as required by weather and/or field conditions.
